In consideration of this registration entry, I, the undersigned, assume the full and complete responsibility for any injury or accident which may occur during my participation in the "Ride for the Red" for the American Red Cross, and I hereby release and hold harmless the sponsor or promoters or other persons or entities associated with this event from any and all injury or damage, whether if caused by myself or by the negligence of the sponsor or promoters or other persons or entries associated with this event. This agreement may not be modified orally or by any individual. I acknowledge that motorcycle riding is an inherently dangerous activity and fully realize the dangers of participating in a motorcycle event and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING, by way of example and not limitation, the following: the dangers of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, the releasee's own negligence, and weather conditions; and the possibility of serious physical and/or mental trauma or injury associated with motorcycle riding.

I agree for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally judged liable on such claim for willful and wanton negligence.
